



END USER LICENSE AGREEMENT: TERMS AND CONDITIONS OF USE

IMPORTANT NOTICE. THIS LICENSE AGREEMENT (THE AGREEMENT) IS A LEGAL AGREEMENT BETWEEN YOU (EITHER AN INDIVIDUAL OR A SINGLE ENTITY) AND Persistent Systems, Inc., AND ITS THIRD-PARTY LICENSORS (“Persistent Systems”). BY INSTALLING OR USING THIS SOFTWARE IN ANY WAY YOU ACKNOWLEDGE THAT YOU HAVE READ, UNDERSTOOD AND AGREE TO THE TERMS OF THIS AGREEMENT. IF YOU DO NOT AGREE TO THESE TERMS, DO NOT INSTALL OR USE THIS SOFTWARE IN ANY WAY, AND PROMPTLY RETURN THE SOFTWARE WITH PROOF OF PURCHASE TO THE PARTY FROM WHOM YOU ACQUIRED IT AND OBTAIN A REFUND OF THE AMOUNT YOU PAID, IF ANY. IF YOU ARE ACCEPTING THESE TERMS ON BEHALF OF ANOTHER PERSON OR A COMPANY OR OTHER LEGAL ENTITY, YOU REPRESENT AND WARRANT THAT YOU HAVE FULL AUTHORITY TO BIND THAT PERSON, COMPANY, OR LEGAL ENTITY TO THESE TERMS.

This Software (as defined below) will be provided to you by electronic mode only.

GENERAL.

“You” and “Your” refer either to an individual person or to a single legal entity. You may also be referred to as Licensee.

“Software” means machine-readable instructions and data (and copies thereof) including middleware and related updates and upgrades You may be separately authorized to receive, licensed materials, user documentation, user manuals, and operating procedures. “Ancillary Software” means all or any portion of Software provided under public, open source, or third-party license terms.

“Order Form(s)” means an accepted customer order (excluding pre-printed terms) and in relation to that order, Persistent Systems quotations, license to use certificates, additional license authorizations, or invoices.

LICENSE GRANT. Subject to the terms and conditions of this Agreement and the payment of any applicable license fees, Persistent Systems grants you a limited, non-exclusive, non-transferable, license to use in object code only one copy of the Software on one device at a time strictly for Your internal business purposes, unless otherwise indicated above or in applicable [Order Form]. Some Software may require license keys or contain other technical protection measures. You acknowledge that Persistent Systems may monitor your compliance with use restrictions remotely or otherwise. If Persistent Systems makes a license management program available which records and reports license usage information, You agree to appropriately install, configure and execute such license management program beginning no later than one hundred and eighty (180) days from the date it is made available to You and continuing for the period that the Software is used.

OTHER RESTRICTIONS. You shall not (a) remove any product identification, copyright notices, or other notices or proprietary restrictions notices from this Software; (b) sell, lease, rent, copy, distribute or transfer this Software to another; (c) use the Software for commercial or financial gain including, but not limited to, use in performing technical, consulting, or training services; (d) cause or permit reverse engineering, disassembly, decompilation or alteration of this Software except to the extent such restriction is expressly prohibited by applicable laws; (e) copy the Software for any purpose, including, but not limited to, archival or backup purposes;



or (f) use the Software for competitive analysis purposes.

To use Software identified as an update or upgrade, You must first be licensed for the original Software identified by Persistent Systems as eligible for the update or upgrade. If the update or upgrade is intended to substantially replace the original Software, after updating or upgrading, You may no longer use the original Software that formed the basis for Your update or upgrade eligibility unless otherwise provided by Persistent Systems in writing. Nothing in this Agreement grants You any right to purchase or receive Software updates, upgrades, or support, and Persistent Systems is under no obligation to make such support available to you. Updates, upgrades, enhancements, or other Support are only available under separate Persistent Systems support agreements. You may contact Persistent Systems to learn more about any support offerings Persistent Systems may make available. Persistent Systems reserves the right to require additional licenses and fees for Software upgrades or other enhancements, or for Use of the Software on upgraded devices.

You must reproduce all copyright notices that appear in or on the Software (including documentation) on all permitted copies or adaptations. Copies of documentation are limited to internal use.

Notwithstanding anything to the contrary herein, if the Order Form(s) identifies that the Software may be utilized on another Designated System(s) (as defined below), Your license to use the Software may be transferred to another Designated System(s). A "Designated System" means a client computer system owned, controlled, or operated by or solely on behalf of You and may be further identified by Persistent Systems by the combination of a unique number and a specific system type, however, Designated System will not include a server system unless explicitly written in Persistent Systems provided Order Form only if you had a prior license for server devices for the Software or its legacy software. Such license will terminate in the event of a change in either the system number or system type, an unauthorized relocation, or if the Designated System ceases to be within Your possession or control.

Software is not specifically designed, manufactured, or intended for use as parts, components, or assemblies for the planning, construction, maintenance, or operation of a nuclear facility. You are solely liable if Software is used for these applications and will indemnify and hold Persistent Systems harmless from all loss, damage, expense, or liability in connection with such use.

Extending the use of Software to any person or entity including You as a function of providing services, (i.e. making the Software available through a commercial timesharing or service bureau) must be authorized in writing by Persistent Systems prior to such use and may require additional licenses and fees. If the Software includes Ancillary Software licensed under the GNU General Public License and/or under the GNU Lesser General Public License (“GPL Software”), a complete machine-readable copy of the GPL Software Source Code (“GPL Source Code”) is either: (i) included with the Software that is delivered to You; or (ii) upon your written request, Persistent Systems will provide to You, for a fee covering the cost of distribution, a complete machine-readable copy of the GPL Source Code, by mail, or (iii) if You obtained the Software by downloading it from a Persistent Systems website and neither of the preceding options are available, you may download the GPL Source Code from the same website. Information about how to make a written request for GPL Source Code may be found in the ancillary.txt file.

When Licensee receives an update, fix, or patch to a Software, Licensee accepts any additional or different terms that are applicable to such update, fix, or patch that are specified in accompanying additional license authorization. If no additional or different terms are provided, then the update, fix, or patch is subject solely to this Agreement. If the Software is replaced by an update, Licensee agrees to promptly discontinue use of the replaced Software.

TERM. Your failure to comply with any term or condition of this Agreement shall result in termination of your license to use the Software. If Persistent Systems licenses the Software for a fixed term, then this Agreement is effective for the fixed term, and Licensee's license is terminated at the end of the fixed term, unless Licensee and Persistent Systems agree to renew it. Immediately upon such termination, you agree to uninstall and agree to delete or destroy the Software, and not retain any copy thereof. At Persistent Systems's request, You will certify in writing to Persistent Systems that You have complied with these requirements.

COPYRIGHT OWNERSHIP. This Software and its source code are proprietary products of Persistent Systems and are protected by copyright and other intellectual property laws. The Software is licensed and not sold. You acquire only the right to use the Software and do not acquire any rights, express or implied, in the Software or media containing the Software other than those specified in this License. Persistent Systems shall at all times retain all rights, title, interest, including intellectual property rights, in the Software and media. Third-party suppliers are intended beneficiaries under this Agreement and independently may protect their rights in the Software in the event of any infringement. All rights not expressly granted to You are reserved solely to Persistent Systems or its suppliers. Nothing herein should be construed as granting You, by implication, estoppel or otherwise, a license relating to Software other than as expressly stated above in the section LICENSE GRANT.

TRADEMARKS. Persistent Systems brand and product names referred to herein are trademarks or registered trademarks of Persistent Systems, in the United States and/or other countries. All other brand and product names are trademarks of their respective holders.

EXPORT RESTRICTIONS. You agree to comply fully with all laws and regulations of the United States and other countries (Export Laws) to assure that neither the Software, nor any direct products thereof are (1) exported, directly or indirectly, in violation of Export Laws, or (2) are used for any purpose prohibited by Export Laws, including, without limitation, nuclear, chemical, or biological weapons proliferation.

None of the Software or underlying information or technology may be downloaded or otherwise exported or re-exported (i) into (or to a national or resident of) any country to which the U.S. has embargoed goods; or (ii) to anyone on the U.S. Treasury Department's List of Specially Designated Nationals or the U.S. Commerce Department's Table of Denial Orders. The Agreement is governed by the laws of the State of California as applied to agreements between California residents entered into and to be performed entirely within California, and each party irrevocably agrees that any disputes arising under or related to this Agreement or the Software shall be arbitrated in the State of California in accordance with the rules of JAMS ("Rules"). The arbitration shall be conducted before sole arbitrator appointed in accordance with the Rules (the "Arbitrator"). The parties hereby agree to service of process and to personal and subject matter jurisdiction of JAMS as provided in



this Section. Notwithstanding the above, Persistent Systems may bring a claim for equitable relief in any court with proper jurisdiction. Upon rendering an award or a decision, the Arbitrator shall set forth in writing findings of fact, conclusions of law and a reasoned opinion explaining the basis of such award or decision, and shall make a determination of which Party shall be considered the prevailing Party, which determination shall be consistent with such reasoned opinion. The Arbitrator shall be empowered to issue injunctive or other equitable relief. Judgment on the award or any other final or interim decision rendered by the Arbitrator may be entered, registered, or filed for enforcement purposes in any court having jurisdiction thereof. No party will bring a claim against the other under or related to this Agreement or the Software as a class or join a class in bringing such a claim. Each party acknowledges that it is waiving such class action rights by this provision.

Each party, on behalf of itself and its affiliates, to the fullest extent permitted by law, knowingly, voluntarily, and intentionally waives its right to a trial by jury in any action or other legal proceeding arising out of or relating to this Agreement. The foregoing waiver applies to any action or legal proceeding, whether sounding in contract, tort or otherwise. To the extent pre-dispute jury trial waiver is not permitted under law and/or to effectuate the intent herein requires a specific affirmation of waiver at relevant time and/or stage of the dispute, each party agrees with the other to waive, its right to have jury trial, at the appropriate stage of the legal proceedings. Each party, on behalf of itself and its affiliates, also agrees not to include any employee, officer or director of the other party or its affiliates as a party in any such action or proceeding. The United Nations Convention on Contracts for the International Sale of Goods is specifically disclaimed. This is the entire agreement between you and Persistent Systems, which supersedes any prior agreement, whether written or oral, relating to this subject matter.

To assist Licensee in isolating the cause of a problem with the Software, Persistent Systems may request that Licensee 1) allow Persistent Systems to remotely access Licensee's system or 2) send Licensee information or system data to Persistent Systems. However, Persistent Systems is not obligated to provide such assistance unless Persistent Systems and Licensee enter a separate written agreement under which Persistent Systems agrees to provide to Licensee that type of support. In any event, Persistent Systems uses information about errors and problems to improve its products and services and assist with its provision of related support offerings. For these purposes, Persistent Systems may use Persistent Systems entities and subcontractors (including in one or more countries other than the one in which Licensee is located), and Licensee authorizes Persistent Systems to do so.

Licensee remains responsible for 1) any data and the content of any database Licensee makes available to Persistent Systems, 2) the selection and implementation of procedures and controls regarding access, security, encryption, use, and transmission of data (including any personally-identifiable data), and 3) backup and recovery of any database and any stored data. Licensee will not send or provide Persistent Systems access to any personally-identifiable information, whether in data or any other form, and will be responsible for reasonable costs and other amounts that Persistent Systems may incur relating to any such information mistakenly provided to Persistent Systems or the loss or disclosure of such information by Persistent Systems, including those arising out of any third party claims.

You may not assign, sublicense, delegate or otherwise transfer all or any part of this Agreement without prior written consent from Persistent Systems, payment to Persistent Systems of any applicable fees, and compliance with Persistent Systems's Software license transfer policies and any applicable third party license terms. Any such attempted Assignment will be null and void. Where an authorized Assignment occurs in accordance with this section, Your rights under this Agreement will terminate, and You will immediately deliver the Software and all copies to the Assignee. The Assignee must agree in writing to the terms of this Agreement, and the transferee



thereafter will be considered “You / Licensee” for purposes of this Agreement. You may transfer firmware only upon transfer of the associated hardware.

You agree that Persistent Systems may use Your name and/or trademark and/or logo on Persistent Systems’s website, press releases, brochures, reports and in other marketing materials to show You as a customer of Persistent Systems.

You agree that Persistent Systems may audit Your compliance with this Agreement. Any such audit would be at Persistent Systems’s expense, require reasonable notice, and would be performed during normal business hours. If an audit reveals underpayments or any other breach of the Agreement, then You will immediately pay Persistent Systems such underpayments together with the costs reasonably incurred by Persistent Systems in connection with the audit and seeking compliance with this section.

U.S. GOVERNMENT RESTRICTED RIGHTS. The Software includes commercial computer software and related documentation within the meaning of Federal Acquisition Regulation (FAR) 2.101, 12.212, and 27.405-3 and Defense Federal Acquisition Regulations Supplement (DFARS) 227.7202 and 252.227-7014(a)(1). The Software is proprietary to Persistent Systems and its third-party licensors. You shall ensure that all users, including, but not limited to employees, personnel, representatives, or agents of the U.S. Government, are permitted to use the Software only as expressly authorized under this Agreement.
